## **1. Welcome note by the Malaysian Physiotherapy Association President**

The President welcomed all those attending for coming to the 58<sup>th</sup> Annual General Meeting of the Malaysian Physiotherapy Association and thanked all members for understanding the need to have the AGM via this platform due to the current pandemic situation. The president continued with his address in the Presidents report.

## **2. Attendance and Apologies**

We had sent invitation to all active members via the new system using the updated MPA website. Invitation were sent to 1,400 active members. 240 members responded and confirmed attending the 58<sup>th</sup> Annual General Meeting 2022.

## **3. Presidents Report for 2020**

This committee was nominated in 2019, for the period 2019-2021. The President presented the activities held for the year 2020

### **3.1 EXCO Job Description**

The Job Description included the President/Vice President/Secretary and Assistant Secretary with their required JD that comes with the position.

### **3.2 Strategic Plan for 2020**

A strategic plan for the period of 2 years (2019 – 2020) for the new EXCO was set.

#### **1. Governance & Administration**

To focus during Annual MPA National Conference and AGM. Improve and increase the membership registrations.

#### **2. Professional Development and Research**

Value added benefit to members. Access to research training opportunities and dissemination of evidence based practice and research and to support professional research and Publications.

### **3. Enhance Role & visibility of the Physiotherapy profession**

Collaborate with stakeholders at national and international levels. To engage with physiotherapist at all states and supporting event and finally to promote visibility and credibility through public education.

### **4. Professional Recognition**

To have awards and recognition to members who contribute towards the profession, credentials and scientific committee

### **5. Provision of quality care to patients/clients**

Develop more professional Evidence based guidelines, Develop more guidelines for Private Physiotherapy, Home based physio etc. To have scientific updates & health talks and hands on workshops.

### **6. Communication Strategies**

E bulletin, Promote efforts of the MPA through media of radio and tv via talk shows etc.

### **7. Grant Provision**

Travel grants to members who want to present papers to international conferences. Training grants to all state members or IPTA or IPTS to organise national student PT workshop.

#### **3.2.1 Governance and Administration**

The goals set were to organise the Annual MPA National Conference and AGM. The goals also included the aim to have an increase in membership registration. The initial plan for the year 2020 was to have a National PT Conference and Workshops in Johor Bharu from the 13<sup>th</sup> to the 15<sup>th</sup> of March in collaboration with Johor PT association. It was an effort by the new EXCO to go out to the other states to make MPA more accessible to our members. Due to the spread of COVID-19 and the increase in numbers the plan had to be cancelled due to the Movement Control Order and we instead organised our AGM to the 12<sup>th</sup> of September 2020 in The Everly, Putrajaya. We also had to limit the number of members who attended the AGM which totalled about 54 but fulfilled the Quorum.

Our efforts to increase membership during the same period there was an increase in membership from 530 in 2018 to 759 in 2019 to 800 in 2020. Also we had an increase in student members from 0 in 2018 to 531 in 2020. There is a marked increase in 2021 with 1,461 active members registered. The new website is able to generate data as needed and has provided the necessary information when prompted by the EXCO. This has helped the EXCO to monitor the progress of members and to keep members updated better on the activities organised by MPA.

#### **3.2.2 Professional Development**

The MPA actively developed Guidelines for Physiotherapists in the country during this pandemic. MPA also worked together with the Technical Committee of BSKB (Bahagian Sains Kesihatan Bersekutu), KKM, to come up with an SOP for Physiotherapist to follow in their practice on the 4th of May 2020.

Due to the pandemic, MPA could not organise live seminars or workshops. So for that reason, the Association switched to organising a series of Webinars adopting technology for

the benefit of members. Our 1<sup>st</sup> Webinar was on the 17<sup>th</sup> of May 2020. The webinars included local and international speakers some of whom were Prof. Dr Suh-Fang Jeng, the Chairperson of WCPT-AWP, Prof. Dr. Kim Bennel and Kim Barthel from Australia, exposing our members to telehealth and tele-support services, Mr Lim Jun Hong from Singapore, Michael Warburton and Dr Kylie Hill from Australia. Also local speakers including past president Mdm Yew Su Fen who talked on Lymphedema, Assoc. Prof Dr Maria Justine who spoke on Sarcopenia, Pn Norfartana who shared on her innovation, invention and design project, that won an award by KKM for her design of a standing table for Paediatric patients and Dr Bhavani who spoke on Education of students in a workplace based assessment. There were good attendance by the Members for the Webinars and we received good feedback from the members who enjoyed the webinars during the MCO.

### **3.2.3 Enhancing the role & visibility of Physiotherapy Profession**

Again due to the pandemic, the MPA had to improvise and come up with a virtual challenge to celebrate the World Physiotherapy Day Challenge 2020. The members were asked to participate in a short video contest.

On the 9<sup>th</sup> of September 2020, the MPA collaborated with KKM to celebrate the World Physiotherapy Day. The event was led by the Head of Profession, Pn Nur Hidayah Ong Abdullah and was sponsored by the MPA included a workshop on an Update in Physiotherapy Outcome Measure and held with adherence to strict SOP.

Assoc. Prof. Dr Mohd. Haidzir Bin Abd Manaf was elected as a council member representing the Physiotherapy Profession in the country in the Allied Health Profession Council for the term 2020 to 2023. The first meeting of the Council members with the Director General of Health was held on the 6<sup>th</sup> of August and he continues to be involved in the development of guidelines in the council for the benefit of all Physiotherapists in the country.

### **3.2.4. Professional Recognition.**

Currently the EXCO is developing Special Interest Groups (SIG) in a few fields including Neurorehab, Musculoskeletal, Paediatrics, Cardiorespiratory, Geriatric, Hand Therapy and Sports. These groups will focus all therapist who are interested in the 7 areas and collaborate to develop these areas. To date there has been very keen interest among members in the SIG and they are sharing information and actively developing each SIG with Clinical Practice Guidelines, Workshops and Protocols. The MPA will further encourage these SIG to develop each fields. In regards to this, there will be a proposal of motion later on by the President.

### **3.2.5. Advocate provision of quality care to patients and clients.**

The MPA has conducted a workshops to develop guideline for physiotherapists in private practice and home care therapy. The workshop was held on the 29<sup>th</sup> of August 2020 and brought together private practitioners to develop the guideline. This guideline helped MPA propose to BSKB a guideline that is acceptable by the private practitioners of both Private Centres and Freelance therapists who offer home care PT which will later fall under the governance of CKAPS (Cawangan Kawalan Amalan Perubatan Swasta). Private practitioners will eventually be registered under CKAPS which includes GP's, Dental and Pharmacists.

The MPA also organised a webinar to make aware of the process to private practitioners to register under MyCPD. The speaker was Pn Nur Alia Binti Zarmani from BSKB. MPA has also organised workshops with BSKB to develop SOP's related to the profession. On the 22<sup>nd</sup> of September 2020 and workshop was organised with BSKB in relation to developing a standardised Neuro Assessment form by KKM. These forms will be suitable for private practitioners as well.

### **3.2.6 Communication Strategy**

MPA has engaged actively via Social Media to better reach out to the members. The MPA used Facebook as the main social media currently, as it is the most actively used by the general public and members and can be easily managed.

The MPA has also developed the Website to make it more interactive and attractive to the Members. The System has been enhanced to allow registration of workshop and seminars through the website. The president encouraged all members to update their personal profile especially their current e mail in the website.

The MPA in 2021 also published its 1<sup>st</sup> Bulletin after long hiatus. It is available via the website. The bulletin highlighted all activities in 2019 and 2020 and will be a regular material that will be published for the members.

### **3.2.7 Grant Provision and Sponsorship**

The MPA has initiated a few programs to help with members financially including travel and training grants. The Grants are for members who plan to attend programs locally or when possible internationally. But to date there had been no application due to the limitation in movement because of the pandemic.

For training, the MPA sponsored 50 members to attend a virtual conference organised by Institute Sukan Negara (ISN) which organised a Sports Medicine and Sports Science Conference on the 4<sup>th</sup> and 5<sup>th</sup> of November 2020.

Due to the Pandemic, the MPA has actively been donating to Physio's around the country by sponsoring N95 masks to hospitals. This initiative was spearheaded by Pn. Halizahanim, Pn. Nur Hidayah Ong Abdullah and Ms Shu. The recipients of the Masks included;

1. University Malaya Medical Centre
2. Hospital Kuala Lumpur

### **3.3 General**

The MPA participated in the ACPT Congress 2020 that was organised virtually by Macau from the 24<sup>th</sup> to the 25<sup>th</sup> of October 2020. Pn Nur Hidayah Ong Abdully was invited as a plenary speaker for the congress in regards to the regulation and services of Physiotherapy in Malaysia.

### **3.4. Puchong Secretariat.**

Ms. Shu did the ground work to obtain all necessary documents including the S&P and Deed stating that the MPA was the Owner. The transfer of ownership was done successfully on September 2020. Now the EXCO will proceed in selling the unit.

The MPA will continue in it's effort to support members by offering Travel and Training Grants provided the situation improves with the pandemic.

  - 4.2.1 Training/workshop conducted by the SIG or State Association
  - 4.2.2 National Student workshop/conference
  - 4.2.3 Research Grants for developing Clinical Practice Guideline

The grants will be at RM5000 per event

#### **3.5.5. World PT Day Celebration**

To support Hospitals/Centres/Universities for World Physiotherapy Day Celebration. The event can be a Public Awareness Program or Sports event. A sum of up to RM1000 will be offered to any hospital or organisation that promoted physiotherapy during the celebrations.

### **4. Confirmation of Minutes of the 56<sup>th</sup> Annual General Meeting**

## **5. Matters arising from the 57<sup>th</sup> Annual General Meeting**

### **5.1 Update on the status of Life Membership and International Membership.**

While amending the Constitution with ROS on the new proposal to have an addition of 2 new EXCO, it was discovered that the MPA constitution required significant change to accommodate the requirements by the ROS system. A workshop was planned for the 17<sup>th</sup> of October 2020 but because of the pandemic situation, it had to be postponed. So the change in regards to the above as well as the general update to the constitution as a whole will be done more extensively and presented at the next AGM. There were no objections from the attendees.

### **5.2 Occupational Therapy and Physiotherapy**

The President updated that all professions is required to present a scope of practice and a standard of practice to KKM in regard to the AHP Act 2016. Any overlapping of responsibilities will be ironed out when each profession presents their scope of practice. It is not only Physio's having overlapping of responsibilities with OT's but also Clinical Psychologists.

Datin Asiah asked if Medical Devices (MDA) Act has any clear mention of use of Electrotherapy by competent professional. The President explained that the MDA Act does not separate the use of machines for specific profession. He further explained that within the Council, eventually, there will be authority to provide proof of Clinical competence to use the devices. Ms. Lily Khong informed that OT were teaching Deep Breathing exercises to patients. The President mentioned that Physiotherapist have to prove that these treatments are exclusive to the profession only to prevent others from practicing it. Datin Asiah hopes that the issue of the use of Electrotherapy can be resolved the soonest. This is to protect the profession and the issue of harm that may come from the improper use of the machine. Mdm. Ooi added that if it is possible for Physio to apply pressure garments will it be an issue considering that there is overlapping of responsibilities. The President said that it eventually will not be an issue if the physio is trained to apply a pressure garments or splints. So long as the therapist is able to show competence in applying the technique.

Mdm Chan Sook Chin also added that it is difficult to claim exclusive ownership to the skills and techniques but we need to be clear of the different scope of practice. We would not want to public to be confused as to the responsibilities between PT's and OT's.

For this reason, the President highlighted the significance of the SIG groups that can share experience and develop therapist in the different fields to ensure comprehensive care is given to the patients. The President is encouraging more members to join in the SIG to develop all the specialties.

### **5.3 Puchong Secretariat.**

Mr President mentioned that it is difficult to sell the unit. Many have approached to rent but the risk will be great. The EXCO is looking to sell the unit and purchase a more suitable place for the use by the MPA. Once the unit has been sold and a suitable unit is found, the proposed purchase will be brought to the members for approval. The incoming EXCO for the period 2021 to 2023 will be tasked with the responsibility to carry out this project.

Mdm Ooi thank the EXCO especially the Vice President for obtaining the Deed and S&P.

## 5.4 Change in Constitution

The addition of 2 EXCO members to the current numbers. The proposal was put forth at the last AGM and received approval. The ROS has approved the amendment in the Constitution to add 2 more Committee Members from the current 4.

In the process of the amendment to the constitution, the Secretary discovered that ROS had its own format for constitution and because of this an effort will be underway after the AGM to review the constitution in its entirety to cater to the ROS format. The changes in the constitution will be presented at the next AGM.

## 6. Finance Report

6.1 We have maintained the Auditors with Lo & CO. for 2020.

6.2 As of 31<sup>st</sup> Dec 2020 the MPA carried over RM1,080,241 balance carried forward. An increase of 10.9% from 2019.

6.3 Income statement shows decrease in income from 2019 to RM160,066, a decrease of 22.2%. Membership fees, on the other hand, had increased by RM122,840, an increase of 14.3%. The surplus after tax had increased by 30% from 2019 to 107,781.

6.4 Expenditure showed reduction by 54.6% to a total of RM 51,760 in 2020. The reduction was because of the pandemic that reduced our expenses from in person workshop. The highest expense for 2020 was the subscription fees which was RM10,953. The subscription is for World Physiotherapy and AWP which MPA pays for 1,300 members. Other major expenditures are for Audit fees, Puchong Building, Maintenance of website.

6.5 The MPA has a total of RM1,069,093 as at 31<sup>st</sup> Dec 2020. (Total of RM776,471 from fixed Deposit and RM292,622 Cash bank balance in Bank). An increase of 11.2%

6.6 As of 11<sup>th</sup> September 2021, the current bank balance was 285,234.03 excluding the fixed deposit. Total amount in FD is RM926,471.01. The total Cash and FD is RM1,211,705.31

6.7 Mdm. Chan Sook Chin asked how MPA is investing the funds currently available? The President says that the purpose of MPA is to give back to the members in a prudent and beneficial manner. As an NGO the organization should not be focused on generating income. Furthermore more income will mean higher payment to the inland revenue board. The suggested focus currently is to purchase a building as a functional Secretariat. That will be an investment in itself.

Mdm Ooi thank the treasurer for ensuring the finances are well controlled and monitored.

6.8 There was a query as to how to ensure junior members benefit. Mr. Secretary highlighted what Mr. Marc said at the previous AGM to ensure we give back to members prudently. Ms. Francesca asked to allot percentages to different activities.



6.9 The Finance report was accepted by all in attendance without any objections.

## **7. State Representative Report**

We currently do not have any state representative reports. The current MPA EXCO is trying to engage back with all the State PT Associations and support them through the MPA. This is a step to re-unite the state Assoc with the MPA and to have a united physiotherapy profession under one Association. The current EXCO is in active engagement with the State PT Assoc. One proposed method is to register the State Association through the MPA and to give them a proportion of the membership fee for their activities (suggested up to 30%). There has been positive feedback from the State Assoc.

## **8. Any Other Business.**

### **8.1 Proposal / Motion to be approved in the AGM**

#### **8.1.1 State Affiliation with the National Body.**

This is an effort by the current EXCO to absorb all State Associations with the parent National Association (MPA). There are currently 8 state physiotherapy associations in the country.

The EXCO realized the limitation it has in organizing events for the whole country. It acknowledges that the state associations has succeeded in creating a new avenue for physiotherapists to grow at state level.

The EXCO had its first meeting with the state leaders and during the MOH Physiotherapy Conference in 2019 and the state association were receptive to the idea of being affiliated to the National Body. The Objective to reach out and bring all Associations under one body was agreed pending discussion on the terms and conditions.

Proposal ;

To elect to unite the State Association with the MPA. Members will be member of both MPA and State Assoc

This is to ensure that there will be activities in all the states. The State Association will take the lead in organizing events for the state members.

1. Create a better network creating standard leveling of the Physiotherapy profession.
2. To allow all members of the National Association to gain benefit irrespective of geographical boundaries.
3. To aid and expedite the delivery and dissemination of information
4. To increase membership subscription.

Mdm. Chan Sook Chin asked if the State Associations are registered with ROS. Mr President confirmed that the State Associations are registered with the respective State ROS. Only those that are registered with ROS are allowed to affiliate with the MPA.

Mdm. Chan further mentioned that the MPA is the recognized professional body and now our effort is to have 14 state Assoc. to affiliate with the MPA. Mr President confirmed that out of the 23 professions in the 774 ACT, MPA is the only Assoc that govern the profession. In any matters arising in regards to the Profession, all government bodies will refer back to the MPA. The President also confirmed that there are only 6 state associations that are looking to affiliate with the MPA. Ms. Francesca asked why not MPA set up regional groups. The President clarified that MPA does not want to create a situation where there will be conflict between MPA Regional Assoc. and the State Assoc.

Ms. Francesca re-iterated that MPA has to ensure that the State Assoc are to follow the same constitution. Ms. Francesca advised to proceed to develop a Regional groups that can later absorb the current State Associations into the MPA. Mdm. Chan asked to see the constitution of the State Association and to ensure that there are no issues that will later creep in when organizing events.

**Vote from Members to agree to develop the proposal of the State Affiliation. Requires further discussion.**

### **8.1.2 The Development of the MPA Journal.**

To develop the MPA Journal, one of the criteria by the KDN is that our constitution needs to state the Scientific Activities organized by the Association. The other way is the approval from the AGM to develop a Journal.

The MPA Journal is the official journal of the Malaysian Physiotherapy Association. The Journal's mission is to publish significant research which has important implications for physiotherapy. The editorial board members will be chosen based on the following criteria ;

1. PhD qualified
2. Scopus PH index is >3

### **8.2 Motions brought up by members to be discussed at the AGM**

To date no motions were put forward to the committee to be brought up for discussion during this AGM.

### **8.3 Presidents Closing message**

The current EXCO (2019 – 2021) thanked all members for their support and continued trust with MPA and hopes the new EXCO will take MPA to greater heights. The President would like to have a united physiotherapy in Malaysia. This includes all therapists from the Public, Private Hospitals, having own private centers or running a Freelance Service. The MPA should look to unite all therapist in all fields. During the pandemic, the MPA was thrust into a difficult situation to cater for all physiotherapist irrelevant of whether the physio is a member of MPA or not. Our President saw great teamwork with BSKB and Pn. Nur Hidayah Ong Abdullah as the Head of the PT Profession and all EXCO. With that the EXCO stepped down to allow the facilitate the election of the new EXCO for the period 2021 to 2023.

### **9.0 Election of EXCO for 2021 to 2023**

The floor received a nomination for Assoc. Prof. Dr Haidzir Manaf to the position of the Election chairman being the President elect. There were no objections to the nomination. He was assisted by the Vice President, Ms Kelly Shu (who also was re-elected to the position unopposed).

This year, the format of the elections had to be changed to accommodate a virtual platform using Zoom. The EXCO members and the Election Committee took advice and guidance on the best way to conduct the elections in this new method.

Time was given for members to nominate candidates for the different positions. Since 1<sup>st</sup> of August till the 31<sup>st</sup> of August 2021. There were no candidates who submitted names to vie for the position of the President, Vice President and the Secretary. So these positions were retained uncontested.

The Chairperson noted there was a motion from Datin Asiah and other members to allow the current EXCO to remain for another term. A vote was conducted to see the general consensus from the attending members.
