1. JOB GRADE, SALARY & ALLOWANCES

Grade	: Executive 3 (E3)
Basic Salary	: RM 1,720.00
Non Clinical Allowance	: RM 60.00 (will be lifted when basic salary reached RM2000.00)
Laundry Allowance	: RM 20.00
Total	: <u>RM1,800.00</u>

Your salary will be credited into your bank account.

2. DUTIES AND RESPONSIBILITIES

You will be reporting to the **Head of Department, Rehabilitation** of KMC with regards to your duties and responsibilities that are revisable from time to time.

You are to give total support and assistance to your immediate superior to ensure the smooth running of the Company.

3. WORKING DAYS AND HOURS

You are required to work according to regulated hours within your department subject to changes from time to time.

4. TRANSFER
