### 4.2 Programme requirements:

Physiotherapy graduates will demonstrate the theoretical, practical and professional knowledge and skills underpinning a wide range of physiotherapeutic skills and interventions.

Graduate physiotherapists will be able to evaluate the indication for, and effectiveness of physiotherapeutic interventions. They will be able to assess the needs of the individual and plan, and execute, safe and effective examination and treatment programmes within the scope of physiotherapy practice.

Physiotherapy graduates will be able to demonstrate skills in research and critical appraisal in order to optimise clinical effectiveness and reflective practice. They will be able to evaluate knowledge which arises from both a theoretical and practice perspective. In addition physiotherapy graduates will engage with Information Technology effectively to inform and support patient care

Furthermore graduate physiotherapists will be able to promote the optimisation of health and well-being in individuals and groups, through education, advice, empowerment and the use of interventions which are within the scope of physiotherapy practice. As such they will adopt a holistic approach to the delivery of physiotherapy, which is responsive to the needs of the individual and service. In addition graduates will be able to recognise and respond to changing demands, without compromising the physiotherapist's duty of care to individuals.

Graduates will be self aware, self directed and sensitive to the needs of others. Moreover, they will be able to demonstrate leadership potential as well as the ability to function effectively within the inter-professional team. Graduates will also be able to appraise the changing role of the physiotherapist and develop skills necessary to meet those requirements. As such they will be able to adapt to the changing healthcare environment and expectations and be able to embrace the role of the physiotherapist as a practitioner, partner, leader, and advocate to the patient.

Graduates will appreciate the broader contemporary issues related to health and social care services and have knowledge and practical experience of health practice from a range of perspectives including inter-professional contributions and relationships, as well as having experience of working in a variety of settings. They will be aware of issues that affect and change physiotherapy practice and roles; these include health and social policies, relevant legislation, ethics, recognition of diversity of needs and the professional framework of practice. This knowledge and understanding will enable the development of effective and appropriate relationships with service users, colleagues and other agencies and develop and promote ethical professional practice that respects diversity.

Graduates will be independent autonomous practitioners who take responsibility for their own professional development and are able to contribute to the safe, ethical and effective delivery of physiotherapy services in a wide variety of inter-professional and multicultural contexts.

Furthermore graduates will be equipped to meet the requirements concerning eligibility to apply for registration with the Health Professions Council (HPC) and membership of the Chartered Society of Physiotherapy (CSP).

**4.4 Grading scheme details:**

Honours Degrees are normally classified based on a weighted average and are awarded as follows:

70% or more First Class

60% to less than 70% Second Class, Division 1

50% to less than 60% Second Class, Division 2

40% to less than 50% Third Class

Unclassified Honours Degrees can also be awarded (Pass only) in order to meet professional body requirements.

Integrated Masters Awards are awarded a Merit at an average mark of 60% across a specified number of credits.

All other Awards of the university are awarded a distinction at an average mark of 70% across a specified number of credits. Foundation degrees are awarded a Merit at an average mark of 55% to less than 70% across a specified number of credits.
