CONTRACT FOR SERVICE

We are pleased to offer you the Contract (hereinafter “Contract”) as a **Physiotherapist** under **Yimura Medicare Sdn Bhd** (hereinafter “Company”).

Terms and Conditions

1. Engagement :
 - a. The Company hereby engages you to render, as a Physiotherapist and not as an employee, the tasks and duties described in Clause 5 hereto and such other services as may be agreed to in writing by the Company and you from time to time.
 - b. You hereby accept the engagement to provide the services to the Company on the terms and conditions set forth herein.
 - c. You shall report directly to the superior assigned by the Company.
2. Contract Period : 11th April 2022 to 11th June 2022, and thereafter automatically renewed and remain in force *OR* until a new Contract being in force.
3. Base of Work : Yimura Medicare, Bangsar Village II.
4. Service Fee :
 - i. Monthly basic pay of **RM2,600.00** with traveling claim allowance up to RM200
 - ii. You are entitled for commission claims (as shown in Appendix) when personal sales reached RM4,000.00 monthly.

A.
You are liable for your own statutory payment required e.g. taxes, EPF, SOCSO, income tax etc.

B.
The Company reserves the rights to impose change or discontinue or add allowance(s), its provisions, terms and conditions, and make adjustment on the amount, either upward or downward, solely at Company’s discretion.
5. Task and Duties : You shall perform the tasks and duties as a Physiotherapist, including but not limited to:
 - a. Attending patients and providing consultations;
 - b. Diagnosing the diseases, physiological disorders and injuries of Patients;
 - c. Providing treatment based on your analytical skills within your knowledge.
 - d. You shall not provide consultations/ treatment for life-threatening and/ or emergency conditions or for matters that you are not qualified to treat. You

shall refer any such Patients to emergency or other appropriate personal care.

e. You shall strictly follow the administrative and operational rules and regulations set by the Company from time to time.

6. Work Schedules : Your work schedules shall be determined by the Company from time to time.

7. Termination Notice : During the contract period, the withdrawal by either party must be provided one (1) month notice in writing or salary in lieu of notice, without assigning any reason thereof.

8. Transfer : You may be subjected to outstation posting to the Company's group of companies and/or related organizations from time to time when it is deemed necessary.

9. Confidentiality : All information pertaining to the conduct of Company's business shall be the property of the Company and you are not allowed to divulge any information to third party even after the termination of your service.

10. Responsibility and Indemnity : a) You report direct to, and execute all instructions from, the Management or any officers designated by the Management.
b) You are required at all times to observe and carry out faithfully and diligently the duties and responsibilities that are assigned to you from time to time, by the Company or the authorized personnel.
c) You shall fully indemnify the Company and save it harmless, from and against all losses, damages, liability, judgments, costs and expenses which it may sustain or be put to resulting from any misconduct, error, omission, or failure to exercise reasonable care, skill or diligence on the part of your duties.

11. Good Conduct & Discipline : a. The Company shall take action(s) on the grounds of any misconducts that is inconsistent with the fulfillment of the expressed and/or implied conditions of the contract, such as but not limited to:-
i. Insubordination.
ii. Stealing or pilfering.
iii. Fighting or using abusive languages or infliction of pain and bodily harm to superiors, customers or colleagues.
iv. Failed to report for forty-eight (48) hours without informing the concerned superior.
v. Drug abuse.
vi. Sexual harassment whether it is visual, verbal, or physical.
vii. Committing any offence that is detrimental to the Company's interest and/or direct/indirect conflict to the Company's business and operation.
b. The Company at its sole discretion shall impose any punishment that deemed to be justified and fit:-
i. Verbal warning.
ii. Issuing a reminder letter.
iii. Issuing a warning letter.
iv. Suspending without pay up to two (2) weeks.
v. Down-grading.
vi. Dismissing without notice.

14. Entire Agreement : This Contract and the Attachments hereto constitute the entire contract between the contracting parties concerning the subject matter hereof. All prior agreements, discussions, representations, warranties and covenants are merged herein. There are no warranties, representations, covenants or agreements, expressed or implied, between the parties except those expressly set forth in this Contract. Any amendments or modifications of this Contract shall be in writing and executed by the contracting parties.

15. The Company reserves the right to make any changes in the above terms and conditions by additions, deletions or revisions at all times.
