APPOINTMENT TO THE POSITION OF LECTURER IN THE FACULTY OF MEDICINE AND HEALTH AT THE INTERNATIONAL MEDICAL UNIVERSITY (IMU)

Mentoring students is also part of your academic duties. The head of your academic department or the university's authorities may assign you other duties from time to time. As part of the teaching-learning activities, you are also expected to participate in CPD activities.

As the medium of instruction in IMU is English, you may be required to sit for an English placement test and to take English improvement lessons, if necessary. In order that our faculty is imbued with the IMU pedagogy, you are responsible to sign yourself up for the following 5 mandatory training programmes within 12 months from commencement of work: -

1. Fundamentals of Teaching & Learning (FTL) from IMU Centre for Medical Education (ICE);
2. Small-Group Learning Facilitator Training from ICE;
3. Mentor Training Workshop from ICE;
4. Student Interview Training from ICE;
5. Basic E-learning License from E-learning.
